- Networking internally and externally

We offer help to providers of system constellations to develop their professional identity through communication platforms which are beneficial for enlightening and resolving discussions between all parties.

The forum collaborates with other international communities.

We encourage the transfer of knowledge and experience at our yearly General Assembly, which is held in combination with our conference. Within the yearly meetings of our research group, we support research and utilize the potential of constellation work. The results and findings are continuously made available to our members.

Together with the University Witten-Herdecke, we are creating a research network and knowledge data base. This enables us the access to academic discourse.

We organise conferences and workshops to encourage personal meetings, locally and nationwide also for professional exchange between constellation facilitators, consultants and users.

### **The membership**

Membership for Organisations costs 300 € per year in developed countries (Europe, USA, Australia, Japan). In growing countries (Central America, South America, Asia) it costs 200 € and in countries in need of support (Africa) 150 € per year. In addition there is an one-time Registration fee of 50 € (developed countries) resp. 35 € (growing countries) or 25 € (Africa).

If you apply for membership after 30.June of a calendar year you will only be charged half the membership fee for that year. The amount for the current year is to be paid by 31 January, respectively within 14 days after confirmation of membership.

We are pleased if you approve a direct debit as this simplifies our administration process enormously.

This is possible for all countries, which payment is in EURO and Monaco and Switzerland.
